### If you are completing this by hand, PLEASE PRINT NEATLY.

- <u>Date submitted</u>: Enter the date this form was completed.
- <u>Check One</u>: Check the type the application is for:
  - NEW: New member. May include previous members whose records have been purged.
  - RENEWAL: Member in good standing paying current dues
  - NEW CARD: Replacement card (see below). Renewals can select this as well, if needed.
- <u>Primary Card #</u>: Enter the gate card number assigned to primary member (individual OR family).
- <u>Hold Harmless Agreement</u>: This is required ANNUALLY. New and renewing members and range users MUST complete the agreement. Replacement cards do not need to check this.
- <u>Membership Plan</u>. SELECT ONLY ONE. These are for those members who pay dues. See the SOP for details on others
  - ☑ Individual: No range users, still can have guests.
  - Family: Can have range users and guests.
  - Range users:
    - Must purchase a card only once, (unless lost, stolen, or defective). Fill out an application (one per user), and list the card number of the primary (in the box above). Cost is \$20.
    - Existing range users have until 2025 to purchase a card (if they don't have one already), cost is \$10.
  - NEW members will be given a card number at orientation. Leave those fields blank.
  - Add the fees (Individual or Family plus card). and place in "Sub-total".
- Gate card: This is for a replacement card ONLY.
  - Lost or stolen: Member or user buys a new one.
  - Defective: Replaced at no charge.
  - FILL IN YOUR CONTACT INFORMATION SO THAT WE CAN CONFIRM THE CORRECT RECORD IS BEING UPDATED.
- <u>NRA annual membership</u>: Choose one. Primary must be an NRA member.

### HOLD HARMLESS AGREEMENT AND LIMITATION OF LIABILITY

#### East End Rod and Gun Club (EERGC)

EERGC officials have taken every precaution to ensure your safety during your visit to the facility and shall not be held liable for any act or omission outside its jurisdiction and control or directly related to negligence on the part of an EERGC participant or any other person on the premises of the EERGC range. Steps taken by the EERGC includes the training of range officers, field operators, management staff, members and customers of this facility.

For purposes of this agreement a "participant" may be: an EERGC Member; part of a Member's household; a Guest of a Member; or just an individual participating in an open event not requiring membership or guest status (participant only).

EERGC participants expressly agree to hold EERGC harmless for any acts or omissions on their part as it relates to: 1) transportation of firearms to and from the facility; 2) handling of firearms; and 3) use of firearms while participating in live-fire events, demonstrations, or training on any of the ranges.

EERGC participants affirm that management has made every effort to instruct them (either through the use of signs, verbal instructions, or written rules) of prevailing safety rules and regulations as a means of ensuring they have a safe, positive and enjoyable visit to the range.

EERGC participants expressly understand that EERGC management reserves the right to refuse access to any person(s) for any reason that might result in a safety violation, damage to the facilities, or who becomes a safety hazard, i.e., they demonstrate unsafe firearm handling practices, a lack of proper training, their use of an unsafe firearm, they become loud, boisterous or disruptive, failure to wear the minimum footwear (sandals), or any other act or omission that is contrary to established criteria, for operating a safe and efficient shooting range.

EERGC participants affirm, by their signature, that they shall refrain from using alcoholic beverages or illicit drugs while on property leased and/or controlled by EERGC. EERGC participants affirm they understand the consumption of alcoholic beverages is expressly **prohibited** on EERGC property, and that any person(s) under the influence of alcohol or illicit drugs shall be denied access to any part of the facility.

EERGC participants affirm that they alone shall assume full responsibility for their own actions while visiting EERGC range and that participants shall be strictly liable for any injury sustained by their act or omission.

EERGC participants affirm that firearms they will use are free from material defects and function properly, to the best of their knowledge. EERGC participants affirm that ammunition used in their firearm(s) has been properly loaded – either by a licensed manufacturer or, if the ammunition has been hand loaded by themselves, that it was done so by following established criteria as contained in leading reloading manuals; and further that said reloads meet or exceed factory specifications regarding safety.

Nothing in this document shall be construed to mean that EERGC is absolved of its responsibilities and obligations to provide a safe, clean, properly designed, and managed firearms shooting facility.

The undersigned asserts under penalty of perjury: 1) s/he can legally possess a firearm; 2) s/he has no criminal nor mental background that restricts him or her from possession of a firearm; 3) s/he has read, understand, and will comply with the rules and requirements set forth above and on the next page of this document; and 4) s/he agrees to hold East End Rod and Gun Club and its assigns, heirs, directors, members, guests, and volunteers harmless from any act or omission for which s/he is directly responsible.

# **Guest and Participant-Only General Policy**

1. Non-members are not allowed access to the range except: in the company of a current member, or to attend a regularly scheduled club match or another club open house event. Persons not belonging to the immediate household of a current member must be in the company of that member. Those who live within 50 miles are to be considered prospective club members and are limited to two "familiarization visits" per year to the range; such persons must become club members before they are allowed further access to the range (matches and open house events excepted).

2. All guests, including non-member relatives, must be accompanied by their member host when shooting on the ranges and guests must shoot from the same firing position as their member sponsor.

3. Members may have up to two (2) guests on the range simultaneously. Each Household member who is a Range User may bring two additional guests, if their Range Orientation status is current.

4. Members are responsible for their guest and must ensure that their guest complies with all safety procedures at all times.

5. Members shall be subject to Disciplinary Action as a direct result of their Guest's conduct/behavior – up to and including expulsion from the club. Any decision regarding Disciplinary Action shall be made by a quorum of the Board of Directors and shall not be reviewable.

### **Range Rules**

1. The Club publishes both General Range Rules, and Rules specific to each part of the range. These are available either by download from the club web site (go to <a href="https://www.eergunclub.com/range-usage">https://www.eergunclub.com/range-usage</a>), in the information boxes installed near flag poles, or as posted around the range.

2. Copies of the General Range Rules <u>may</u> be handed out during public events; otherwise, members and users must insure that their guests have the opportunity to review the rules before shooting.
