 - 2023 Elections:
 - There being multiple resignations in 2021, continuity in board membership is necessary for continued operations. The SOP requires President and Vice-President to be up for election on alternate years.
 - Bypass of SOP for the President and Vice-President is recommended. The treasurer transition is addressed separately.
 - The By Laws limits officers to no more than 2 terms in the same position, so we will require new candidates for Treasurer. See proposed schedule (attached).

Club financial operations:

- The pending change of Treasurer presents a challenge for the Club, as Stacy has been the mainstay of finances for several years, maintaining books, processing applications, and paying bills. Continuity of these activities is key for the club to continue to operate. However, the level of effort to maintain the books and process membership applications has been a strain for Stacy, as a volunteer.
- The By Laws provide for a "paid Treasurer", but I propose contracting out to an independent bookkeeper to process applications, pay bills, and maintain the club books (using QuickBooks, as required by the By Laws). The position of Treasurer remains, who would then work with the bookkeeper to manage club finances and report to the Board. Only club officers will sign checks.
- The proposed solution meets the intent of the By Laws, but does not follow the letter of them. The By Laws, which are already in need of update, will have to be revised to reflect this. This also supports the board's intention to have an operating budget by January 2023.
- An experienced bookkeeper, willing to take on these duties, has been identified. This person is also experienced in requesting grants. The charge is \$30 per hour, with an initial set up cost not to exceed \$3000 (100 hours), and not to exceed \$600 per month (20 hours). No contract has been signed.
